⁶ At the time of publication, one graduating Dental Hygiene class has taken the National Board for Dental Hygienists Examination (NBDHE). 13/16 students passed the exam, an 81% pass rate. 16 students have taken the CDCA Clinical and Prometric Exams, and 16/16 passed both exams.

⁷ The PTA yearly pass rates were calculated based on students who graduated between October 1, 2015 and October 1, 2017. 48/48 test-takers passed the National Physical Therapy Exam (NPTE) in 2017. 55/56 test-takers passed the NPTE in 2016. 46/46 test-takers passed the NPTE in 2015.

⁸ The VTNE pass rate was calculated using the number of first time test takers that attempted the exam from July 1, 2014 through June 30, 2017.
